## 4.0 REPORTS FOR APPROVAL BY COUNCIL DELEGATION

### 4.1 MAHOGANY BOULEVARD- INSTALLATION OF NO STOPPING YELLOW LINES.

#### PROCEEDINGS IN BRIEF

Cr Jose Menano-Pires discussed the need for Council to have a consistency for where we have yellow lines and white lines marked on the roads and enquired about Council's Standards.

Phil Devon explained that this matter is being addressed and some issues will be made consistent, ie: stop vehicles parking near pedestrian crossings.

Approved by exception.

#### RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports the:

- A. The installation of 20m length of unbroken No Stopping yellow lines on both sides of Mahogany Boulevard between Garden Street and the eastern sides of driveways No's 1 and 2 Mahogany Boulevard.

- B. The installation of a 10m statutory No Stopping yellow line at eastern side of the intersection at Acacia Circuit and Mahogany Boulevard.

#### **4.3 VUKO PLACE, WARRIEWOOD- INSTALLATION OF 10P PARKING RESTRICTION**

##### **PROCEEDINGS IN BRIEF**

Cr Jose Menano-Pires enquired why Council doesn't use this sign elsewhere, ie: "No Parking – motor vehicles excepted".

Phil Devon explained that we use this sign when owners of campervans and trucks use some roads for long term parking, however, this sign still allows residents to park there with no 10P parking restrictions.

Adele Heasman enquired why there appear to be so many signs along Vuko Place.  
Phil Devon explained that these 10P parking signs are placed on existing power poles.

Adele Heasman thanked the Traffic staff for moving this shared path to the other side of the road.

Adele Heasman requested recommendation should read: "Installation of shared path along south side of Abbott Road".

Phil Devon agreed this can be done. He also advised that the Netball Association is happy with this outcome, noting that works are only carried out Monday to Friday, not on weekends when Netball games are on.

Phil Devon advised that Council Rangers will enforce the No Parking and No Stopping rule.

- A. A No Parking restriction on the north side of the street between the driveway serving No.16 Carey Street and the existing No Stopping sign in the cul-de-sac.
- B. A statutory 10m length of No Stopping on the east side of Stuart Street south of its intersection with Carey Street.
- C. A No Stopping restriction across the Little Manly Point carpark's driveway. Relocation of the existing 7P Permit Parking Sign from the power pole to approximately 10m from the carpark's driveway is also proposed.

#### **4.9 ROSEBERRY STREET, BALGOWLAH - SHARED PATH, RAISED PEDESTRIAN CROSSING AND REFUGE ISLAND**

##### **PROCEEDINGS IN BRIEF**

Adele Heasman is concerned about the speed of bikes that are more prevalent in some areas here and enquired about how we can protect our pedestrians and make the bike riders more aware of pedestrians, ie: is Council able to enforce speed limits for bikes?... or place "stoppages" on the paths to slow the bikes down.

Sgt Nino Jelovic advised that quite often, these issues don't get addressed until an accident occurs.

Approved by exception.

## RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports the:

- A. Construction of a 2.5m shared path on the north side of Koorala Street from Condamine Street to Roseberry Street.

Phil Devon explained that this cul-de-sac ends at a headland natural reserve area, and therefore, no residents are not affected.

Jose Menano-Pires stated that he is pleased with this explanation and also concurs with the recommendation.

Jose Menano-Pires suggested that all turning circles in cul-de-sacs require No Parking signs.

##### **PROCEEDINGS IN BRIEF**

Adele Heasman enquired why these Standard Entry and Repeater treatments go out into the North Steyne Road at all?

Phil Devon explained that we are bringing them back to the intersection and from the first laneway, to allow vehicles to slow down when driving towards North Steyne Road.

Vicki Walker advised that we are trying to protect pedestrians before entering North Steyne Road.

Phil Devon advised that these are “narrowing devices” to slow traffic down.

Adele Heasman enquired whether more signs can be erected on both sides of the road in this zone and create a raised area as well, as the speed zones change from 40kmh, to 30kmh to 50kmh along a short length of the road - which is very confusing to drivers.

Phil Devon advised that we can look into this issue in July.

Adele Heasman enquired whether there is traffic data for this zone?

Vicki Walker advised that a “Before & After” Traffic Data Report is currently being collated so that a comparison can be carried out – which she will forward onto Phil Devon.

Vicki Walker also mentioned that a recent crash study revealed that most crashes occur over a 24 hour period – not just in peak hour times.

Cr Jose Menano-Pires enquired whether a speed camera or a radar will be introduced in this area.

Peter Carruthers advised that he is looking into this matter.

Approved by exception.

## 4.22 OLIVER STREET AND BENNETT STREET - HYBRID DEDICATED CYCLEWAY AND SHARED USER PATH CONNECTING FRESHWATER VILLAGE AND CURL CURL SPORTS PRECINCT

### PROCEEDINGS IN BRIEF

Cr Jose Menano-Pires enquired whether these dedicated cycleways will conflict with shared paths and driveways and questioned who will be using these cycleways.

Phil Devon explained that this is a State funded project which will be completed by August this year. Families, schoolchildren and recreational bike riders will be using these cycleways.

There are 2 options ( 1(a) and 1(b)) for on-road 2-way cycleways. We have received responses from 500 people. It was noted that Trial 1(a) received more feedback.

Adele Heasman stated that residents are in favour of off-road linkages from Manly to Dee Why.

Phil Devon explained that this will be a hybrid of a shared user path connecting education precincts, ie: Freshwater Campus to Harbord Primary School to Manly Selective School. It will also form a link between Manly/ Queenscliff/ Dee Why, noting the Dee Why beachfront area will be an off-road shared user path.

Phil Devon advised that this is already an unprotected cycleway and once this project is completed, it will only have a 2km impact in a minimal risk location, with only 19 car spaces being lost on the eastern side of the road (and motorists can park in the cross streets).

Approved by exception.

## RECOMMENDATION TO TRAFFIC COMMITTEE

That the Traffic Committee supports the:

- A. Installation the hybrid design of sections of shared user path and separated cycleway along the eastern side of Oliver Street between Freshwater Village and Brighton Street. (Attachment 1)

## 6.0 GENERAL BUSINESS

### 6.1 PITTWATER ROAD, MANLY – Roundabout, between Harris Farm & Collingwood Street

#### PROCEEDINGS IN BRIEF

Adele Heasman enquired about the process to make this busy roundabout intersection safer for pedestrians at the corner of Collingwood Street outside Harris Farm, Manly.

Phil Devon advised that this has been nominated through TfNSW as a “Black Spot” for the for the 2022-23. Peter Carruthers said they are still waiting for the results of the nomination process.

Phil Devon advised that we have a scaled-down proposal for placing a pedestrian refuge in Pittwater Road

## **6.2 GRIFFITH STREET, MANLY – No Parking sign**

### **PROCEEDINGS IN BRIEF**

Adele Heasman enquired if a No Parking sign can be placed outside Manly West Public School, noting that a trailer has been parked there for a long period.

Phil Devon advised that a “No Parking, Motor Vehicles Excepted” can be considered at this location.

**Phil Devon requested Adele Heasman to send him a request for this sign to be erected and advised this will be followed up and discussed at next month’s LTC meeting.**

## **6.3 PITTWATER ROAD / EUROBIN STREET, MANLY – Right arrow into Eurobin Street from Pittwater Road**

### **PROCEEDINGS IN BRIEF**

Adele Heasman enquired about the process to apply for the inclusion of a right arrow at the traffic lights on the corner of Pittwater Road into Eurobin Street, Manly.

**Adele Heasman will send this request to Phil Devon to investigate and respond.**

## **6.4 McCARRS CREEK ROAD, CHURCH POINT – Speed Humps**

### **PROCEEDINGS IN BRIEF**

Phil Corbett advised that he lives in McCarrs Creek Road, Church Point and he has had some local residents complain about the 21 speed humps that Council has placed along McCarrs Creek Road, Church Point to slow the traffic down. Some residents living along McCarrs Creek Road are unhappy with the amount of speed humps placed along a short stretch.

Phil Corbett requested whether a few speed humps can be removed as he and some other local residents who live along that road, feel there are too many speed humps along such a short section of road, as they create noise pollution from cars, trucks and tradie utes braking when approaching these speed humps (21 speed humps have been placed along a 1.7km stretch of McCarrs Creek Road). Two residents have also complained about the sharpness of the speed bumps and enquired whether different speed humps can replace the current “sharp” humps (due to medical reasons of the bumpy ride).

Andrew Johnston and Sgt Nino Jelovic both agree with the residents living in this section of McCarrs Creek Road - that the number of accidents along this stretch of road has decreased, as it has minimised speeding. However, they also understand the residents who have complained about the noise factor that these speed humps have created.

Andrew Johnston and Sgt Nino Jelovic both agree to leave this matter to Council’s Engineers to decide on possible improved situation here.

Phil Corbett indicated his support for Council Engineers to investigate the matter.

Phil Devon advised that initially, the reason for placing speed humps along this stretch of road was to slow down the traffic and to maintain a safe road for cyclists, pedestrians and other motorists.

Cr Jose Menano-Pires advised that there was a 90-day accident study carried out recently along McCarrs Creek Road up to Terrey Hills. The results showed that 99% of cars travelled between 50-60km/h, however, bikes were mostly involved in accidents.

Phil Corbett requested a few speed humps be removed and placed closer to the Reserve section of McCarrs Creek Road, to slow the traffic down around the bends.

Phil Devon indicated that he has Phil Corbett's earlier submission on file, regarding reducing the number of speed humps.

**Phil Corbett will re-submit a report to Phil Devon for his investigation and for forwarding onto the RMS for feedback.**

**Phil Devon and Cr Jose Menano will discuss this matter and advise the Committee the outcome at the May LTC meeting.**

#### **6.5 McCARRS CREEK ROAD, CHURCH POINT – Vegetation Clearing inside bend near Walker Place.**

##### **PROCEEDINGS IN BRIEF**

It was requested that vegetation clearing be carried out inside the sharp bend along McCarrs Creek Road, Church Point across from Walker Place - as motorists and cyclists are unable to view oncoming traffic around the bend when exiting out of Walker Place.

**Phil Devon advised that he will lodge a CRM to have this vegetation cut back.**

#### **6.6 NORTH STEYNE ROAD, MANLY – Parking**

##### **PROCEEDINGS IN BRIEF**

Cr Jose Menano-Pires requested feedback from the Committee about the safety of car parking along North Steyne Road, Manly, as some trucks, tradie utes and surfers with surfboards on their roof racks, are causing safety hazards when backing into the car spaces, resulting in the rear of their trucks and vans and loads encroaching onto the shared path.

Cr Jose Menano-Pires also requested consistency of the car parking along North Steyne Road, so that all vehicles either park front or rear to kerb, as motorists are confused with the current signage.

Adele Heasman advised that we have a Duty of Care to our residents and visitors to our Northern Beaches regarding safety issues that need to be addressed and need a solution.

Phil Devon suggested that where the shared path is set back in a few sections, Front or Rear to Kerb Parking can be investigated, so that trucks and tradie utes backing into the car spaces, won't be encroaching onto the shared path, taking into consideration the heritage Norfolk Pine Trees planted along the shared path area.

**Cr Jose Menano will email his submission to Phil Devon for discussion at the next LTC meeting in May, as this matter needs to be addressed due to safety concerns.**



**6.7 WAKEHURST PARKWAY, NARRABEEN – Flood Mitigation**

**PROCEEDINGS IN BRIEF**

Vicki Walker enquired about the status of the Wakehurst Parkway Flood Mitigation report and advised she has forwarded this request onto Phil Devon for his response.

**Phil Devon and Vicki Walker will discuss this matter, which will be reported to the Committee at next month's LTC meeting in May.**
