You may use this form to apply for a temporary approval to vend from an approved outdoor dining location in Northern Beaches Council. This is a temporary measure to support businesses during the latest lockdown.

The approval:

- Only permits the sale of pre-packaged and pre-prepared food.
- Does not permit any food handling or preparation e.g. use of coffee machines, sandwich preparation, use of any cooking appliances
 or heating equipment.
- Is subject to compliance with the conditions associated with the approval.

Approvals are valid on a temporary basis and subject to change at Councils discretion based on the current Public Health Orders under the Public Health Act 2010.

- 1. Ensure that all fields have been filled out correctly. Failure to complete all fields may result in rejection of the application.
- 2. Submit the application to: council@northernbeaches.nsw.gov.au
- 3. Application must be accompanied by the following documents:
 - Updated Covid Safety Plan that includes the proposed outdoor operation
 - Public liability insurance that covers outdoor vending
 - Current outdoor dining approval letter
- 4. An approval letter must be issued by Council Prior to outdoor operation.
