Description of Goods/Services/ Consultancy	<p>The full scope of works required following the storm involves the construction of coastal protection works at 11 individual sites along Collaroy to Narrabeen Beach. These 11 sites cover 490m of land adjacent to the beach and are interspersed between the areas of private land also requiring protection.</p> <p>The timing and final detailed design for the works to protect public assets is dependent upon residents having applications for private protection works approved and the works constructed.</p> <p>The forecast timeline for both public and private works is expected to commence in 2019 and be completed in 2021. Due to the above extensive timeframe Council have decided to commence construction as separate work packages with stage 1 being the area alongside Collaroy car park.</p> <p>Public works are proposed at Collaroy car park with construction planned to commence in April 2019. This represents the largest Council site requiring protection and approximately 250 metres of the 490 metres in total of public land that requires protection. It is proposed that a tender response be sought for the works required at Collaroy car park, along with a schedule of rates required to complete the remaining coastal protection works over the period between 2019 and 2021.</p>
