Part 4: Application process and usage terms and conditions

<p>Please read the following prior to completing you applications</p>
<ul style="list-style-type: none">• Each application will be assessed individually and the applicable fee applied. The agreement and invoice will be forwarded.• Upon payment and signing the agreement Council will issue a permit sticker. This is to be affixed to the vessel and be clearly visible at all times. Failure to comply will result in an infringement being issued.• You will be issued a specific numbered bay for the storage of the nominated watercraft.• Watercraft is stored entirely at your risk and Council will not accept any responsibility for any damage caused to the watercraft.• You will be contacted annually to pay the required fee. If you fail to pay any fee the watercraft will be removed and an impounding fee will be applied.• If you do not remove the watercraft or other equipment after the Agreement has been terminated, the items will be removed and may be disposed of.• Council has the right at any time and for any reason to terminate an agreement.• You must advise Council in writing if you no longer require the use of the watercraft storage area.• You cannot "on-sell" or transfer the agreement under any circumstances.• You must give Council immediate notice of any damage, defect or deterioration affecting the watercraft storage area.
