#### 1.0 APOLOGIES

## 2.0 CONFIRMATION OF MINUTES OF PREVIOUS MEETINGS AND DECLARATION OF PECUNIARY AND CONFLICTS OF INTEREST

#### 2.1 MINUTES OF NORTHERN BEACHES COUNCIL LOCAL TRAFFIC COMMITTEE HELD 6 FEBRUARY 2024

#### RECOMMENDATION

That the Minutes of the Northern Beaches Council Local Traffic Committee held 6 February 2024, copies of which were previously circulated to all members, are hereby confirmed as a true and correct record of the proceedings of that meeting subject to the following amendments:

General Business:

4.7.23 - Item 6.3 Forest Way, Belrose Pedestrian Safety should read:

Wakehurst Parkway upgrade - should read Wakehurst Public School upgrade.

Mr Phil Corbett requested that any responses from TfNSW on this matter also be distributed to Mr Matt Cross MP in addition to Michale Regan MPs office (Sally Carmody).

10.10.23 – Item 6.3 Wakehurst Parkway, Deep Creek, North Narrabeen – Safety Road Crossing should read:

Mr Phil Corbett requested an update be distributed to Mr Rory Amon when Sam Morley is advising Michael Regan's office.

Sam Morley advised that this matter is currently sitting with management in TfNSW. An update to Mr Michael Regan's office and Mr Rory Amon's office will be given shortly. She also advised that the makeshift pathway that has been constructed by cyclists under the bridge was a matter for Council to resolve as this was not TfNSW land.

#### 2.2 DECLARATION OF PECUNIARY AND CONFLICTS OF INTEREST

- Item 4.9 James Brocklebank advised he had a non-significant and non-pecuniary interest as he is a resident of the area of Elanora Heights, street disclosed to Committee.
- Item 4.2 Cr Jose Menano-Pires declared that he had a non-significant and non-pecuniary interest and he lives in the area. Under Department of Local Government guidelines, no further action needs to be taken as the proposals do not restrict themselves to any home, but to a wider area, which he represents as a Councillor. He tabled a Declaration of Interest

#### 3.0 REPORTS TO PROCEED TO COUNCIL FOR APPROVAL

SPEAKERS WERE INVITED INTO THE MEETING TO ADDRESS THE TRAFFIC COMMITTEE:

#### ITEM 4.4 - FRENCHS FOREST WARD - LOCAL ROAD SAFETY PROGRAM - BEACON HILL

#### Speaker 1 – Katherine Stackpool – 56 Ryan Place, Beacon Hill

Cr Jose Menano-Pires welcomed Ms Stackpool who advised the Committee that she was not in support of the proposal. Ms Stackpool advised the noise of acceleration and deceleration of vehicles using the speed hump would adversely impact the quality of her life. Ryan Place was usually a quiet street with the traffic issues restricted only to one hour per day, five days per week. In 2020, there was removal of parking to improve traffic flow, whereas now the installation of the speed hump proposal would restrict traffic flow.

Ms Stackpool also advised the proposed raised threshold in Elliot Street created a safety issue for residents using the access driveway to No.6 Elliot Street. The height of the raised threshold did not take into account the camber of the road and suggested the raised threshold be relocated.

#### Speaker 2 – Grant MacDonald – 10 Kandra Road, Beacon Hill

Cr Jose Menano-Pires welcomed Mr MacDonald who advised the Committee that he was not in support of the proposal. The raised threshold in Kandra Road was to be installed directly adjacent to his bedroom and the noise impact of acceleration and deceleration of vehicles using the speed hump would adversely impact the quality of his and his family's lives, especially the tradie utes bumping over the device with tools in the back, many of which used the roads in the afternoon. He suggested that rather than speed humps, maybe a better solution would be the installation of chicanes to slow the traffic.

*Cr Jose Menano-Pires thanked Ms Katherine Stackpool and Mr Grant MacDonald for addressing their concerns to the Local Traffic Committee and advised them the Traffic Committee will discuss the matter further and get back to them.*

## ITEM 4.2 - FRENCHS FOREST WARD - LOCAL ROAD SAFETY PROGRAM - FRENCHS FOREST

#### Speaker 1 – Mike Franklin – 1 Meredith Place, Frenchs Forest

Cr Jose Menano-Pires welcomed Mr Franklin who thanked the Committee for the opportunity to discuss the proposal. Mr Franklin outlined several options and advised the issue was congestion, due to the volume of traffic using Fitzpatrick Avenue East as a 'rat run' during weekly peak hour times (between 7am and 8:45am) and not speeding. He also advised that there were communication issues regarding this meeting and that he had not been given enough notification of the meeting.

#### Speaker 2 – Neil Hodgson, 17 Fitzpatrick Avene East, Frenchs Forest

Cr Jose Menano-Pires welcomed Mr Hodgson who advised the Committee that his experience of living on Fitzpatrick Avenue East for over 35 years was not speeding vehicles, but rat-running traffic, as a result of the failure of the Warringah Road upgrade to adequately cater for through traffic. Congestion was bad only on Tuesdays, Wednesdays and Thursdays between 7am and 8:45am. The speed humps and associated fencing would also look unsightly and reduce the amenity of the area. He invited Committee members to meet with him onsite at any of the above times to see what the issues were. He also advised that the majority of the residents he had spoken with did not support the proposals. He also suggested if there were any funds, the resealing of Fitzpatrick Avenue East would be better value for money.

#### Speaker 3 – Ms Alicia Kemmers – 8 Fitzpatrick Avenue East, Frenchs Forest

Cr Jose Menano-Pires welcomed Ms Kemmers who also outlined several options, similar to Mr Franklin and suggested a solution similar to the traffic restrictions in Grace Avenue, Frenchs Forest could be applied to Fitzpatrick Avenue East. She did however, raise a concern that any signposted restriction would be ignored by motorists as this had been her experience with the STOP restriction at Rangers Retreat Road and Fitzpatrick Avenue East. Ms Kemmers also noted that the traffic was less during school holiday periods. Ms Kemmers also suggested linemarking along Fitzpatrick Avenue East would assist traffic to keep to the correct side of the carriageway. Ms Kemmers also advised that many of the residents she had talked to had not received consultation letters.

#### Speaker 4 – Ms Bronwen Henderson – 24 Fitzpatrick Avenue East, Frenchs Forest

Cr Jose Menano-Pires welcomed Ms Henderson who advised that the Warringah Road upgrade had impacted significantly on local residents during morning peak hours. She also advised that local residents do not want the proposals and the options the previous speakers had discussed, could be for a trial period. She also noted that after the morning peak hour, there were little traffic issues in Fitzpatrick Avenue East.

Cr Jose Menano-Pires thanked the four speakers for addressing their concerns to the Local Traffic Committee and advised them that the Traffic Committee will discuss the matter further and get back to them.

The Traffic Committee discussed this matter further – see Proceedings in Brief and the Recommendation to the Committee in Minute Item 4.2

#### 4.0 REPORTS FOR APPROVAL BY COUNCIL DELEGATION

#### 4.1 CURL CURL WARD - OLD PITTWATER ROAD, BROOKVALE - TIMED PARKING PROCEEDINGS IN BRIEF

Deferred to next Local Traffic Committee meeting.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee defer this recommendation until the next Local Traffic Committee Meeting.

#### 4.2 FRENCHS FOREST WARD - LOCAL ROAD SAFETY PROGRAM - FRENCHS FOREST

#### **PROCEEDINGS IN BRIEF**

Council wanted to ensure all roads in this area were of a low speed environment and consistent with 40kph speed restrictions. Phil Devon also agreed that there was not currently a crash history issue to support the calming proposals. The problem was that Fitzpatrick Avenue East had turned into a 'rat-run' for morning peak hour.

Ms Sally Carmody expressed concerns about what the Committee is trying to achieve. Has the Warringah Road upgrade really made the 'rat-run' worse? The issues, from a resident perspective, appear to be not so much speeding, but congestion. As she sees it, there are four sets of lights on Warringah Road that impact traffic flow and these need to be phased to prevent rat-running through residential streets.

Cr Jose Menano-Pires advised that there were no speed issues, some roads were 50kph in the area, Fitzpatrick Avenue East was a wide road and a footpath nearly the entire length of the road, and in some places had a footpath on both sides. He requested Transport for NSW model traffic lights phasing along Warringah Road, especially at Hilmer Street and Forest Way intersections, to optimise traffic flow in Warringah Road and minimise the 'rat-run' in Fitzpatrick Avenue East.

Senior Constable Adam Castleden advised there would be enforcement issues at these locations if Council/TfNSW were to introduce turn bans or No Entry restrictions and that local residents will inevitably get caught out by the enforcement activities and not like it.

Mr James Makasiale advised that there were historical issues with bus access through this area. If there was to be a 'No Left Hand Turn' or No Entry restriction on Fitzpatrick Avenue, buses would need to be exempted as this was a school bus route.

After general discussion about various options, it was agreed by the Committee to approve the proposed changes and deletions suggested by Cr Jose Menano-Pires.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports:

- A. A request for TfNSW to investigate options, including modelling, for traffic light phasing at Hilmer Street and Forest Way intersections to optimise throughput on Warringah Road.
- B. Installation of raised pedestrian crossing with associated kerb blisters and pram ramp realignment at existing children's crossing on Currie Road (outside Our Lady of Good Counsel Catholic Primary School).

- C. Installation of raised pedestrian/cycle crossing outside No.27 Fitzpatrick Avenue East with a reduced height of 75mm.
- D. Installation of painted Stamping (brick pattern) for street entry outside the following properties:
  - a. No.46 Maxwell Parade
  - b. No.3 Fitzpatrick Avenue East
- E. Installation of raised threshold outside No 45 Maxwell Parade and the raised threshold proposed outside No 9 Maxwell Parade to be moved to a revised location.
- F. Replacement of concrete medians with painted medians at the intersection:
  - a. On Fitzpatrick Avenue East at the intersection with Karingal Crescent
  - b. On Fitzpatrick Avenue East at the intersection with Panorama Crescent
  - c. On Yarraman Avenue at the intersection with Gilbert Place
- G. Kerb Extension, connecting footpaths and kerb ramps on Bantry Bay Road at the intersection with Yarraman Avenue.
- H. One lane Slow Point outside No. 25 Maxwell Parade
- I. Install stop control at Kanya Street and Rangers Retreat Road intersection
- J. Install double barrier lines on Rangers Retreat Road at intersection with Kanya Street
- K. Further investigation by Council into the following options:
  - a. Physically close Fitzpatrick Avenue East at Warringah Road
  - b. No Entry to Warringah Road from Fitzpatrick Avenue East between the hours or 7:00am and 8:45am Monday to Friday
  - c. No Entry at Karingal Crescent on Fitzpatrick Avenue East between 7:00am to 8:45am Monday to Friday
  - d. No Left Turn from Panorama Avenue into Fitzpatrick Avenue East 7:00am to 8:45 am Monday to Friday.

#### 4.3 FRENCHS FOREST WARD - ELECTRIC VEHICLE STREETSIDE CHARGING -ALLAMBIE ROAD, ALLAMBIE HEIGHTS

#### **PROCEEDINGS IN BRIEF**

The Traffic Committee agreed to support the recommendation.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports the 12 month trial of:

1. Installation of '3P 8AM – 8PM EVERYDAY EV ONLY WHILE CHARGING' at No.118 Allambie Road, Allambie Heights.

#### 4.4 FRENCHS FOREST WARD - LOCAL ROAD SAFETY PROGRAM - BEACON HILL

#### PROCEEDINGS IN BRIEF

Cr Jose Menano-Pires advised Phil Devon and Jackline Shahho met on site with residents to discuss issues. It was noted that the yellow No Stopping linemarking in Ryan Place has faded and will need to be renewed.

Speeding in Ryan Place was an issue, but there were concerns about the proposed speed hump adjacent to No.56 Ryan Place and the location of the threshold on Elliot Street near No.5.

Cr Jose Menano-Pires agreed that the two issues raised by the first resident speaker could be addressed as previously discussed with staff. The proposal is now to replace the speed hump at No 56 Ryan Place with a tactile treatment in Ryan Place further up the road towards Elliot Street; and in Elliot Street - relocate the raised threshold closer to Beacon Avenue, due to the steepness of the street and impact upon the access road to a number of resident properties.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports the installation of:

- A. A Traffic Island, Kerb Build-out, and "Stop" line marking and signage on Kalianna Crescent at the intersection of Doulton Avenue and Willandra Road.
- B. Marked double barrier lines on Willandra Road, Doulton Avenue, Kalianna Crescent, Elliot Street, Beacon Avenue and Ryan Place.
- C. Painted Stamping (brick pattern) for street entry at No.63 Beacon Avenue.
- D. Raised threshold outside the following properties:
  - a. No.1 Beacon Avenue
  - b. No.15 Beacon Hill Road (on Ryan Place)
  - c. No. 20 Elliot Street
  - d. No. 53 Beacon Avenue
- E. Speed humps (Watts Profile) outside the following properties:
  - a. No.1 Doulton Avenue
  - b. No.13 and No.33 Ryan Place.
- F. One lane Slow Point outside the following property:
  - a. No.21 Beacon Avenue
- G. 'Slow' road stamping to be installed outside the following properties:
  - a. No. 48, No. 75 and No. 91 Ryan Place
  - b. No. 4 and No. 21 Wedgewood Crescent
- H. A speed hump previously approved outside No.11 Kandra Road, is proposed to be changed to a chicane and will be installed as part of this proposal.

That the Traffic Committee supports the:

1. Introduction of No Parking Motor Vehicles Excepted restrictions on the northern side of New Street East, between Curban Street and Gourlay Avenue, Balgowlah Heights.

#### 4.7 MANLY WARD - RAISED PEDESTRIAN CROSSING - BALGOWLAH ROAD, FAIRLIGHT NEAR ROUNDHOUSE PRE-SCHOOL

#### **PROCEEDINGS IN BRIEF**

The Traffic Committee supported this recommendation.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports the:

- A. Installation of a Raised Pedestrian Crossing on Balgowlah Road east of Daintry Street,
- B. Installation of kerb blisters to retain the parking bays and improve the visibility of pedestrians.
- C. Installation of a footpath slab as shown on the attached Plan.

#### 4.8 MANLY WARD - ACCESS TO QUEENSCLIFF HEADLAND - RAISED PEDESTRIAN CROSSING

1. Installation of a raised pedestrian crossing on Greycliffe Street, east of the intersection with Bridge Road.

#### 4.9 NARRABEEN WARD - ELANORA ROAD AT WEEROONA AVENUE ELANORA HEIGHTS - RAISED PEDESTRIAN CROSSING

#### PROCEEDINGS IN BRIEF

The Traffic Committee supported this recommendation.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports the:

A. Conversion of the existing raised threshold to a raised pedestrian crossing.

#### 4.10 NARRABEEN WARD - POSSUM WAY, WARRIEWOOD - NO STOPPING PROCEEDINGS IN BRIEF

The Traffic Committee supported this recommendation.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports the:

1. Installation of No Stopping Unbroken Yellow Kerb Line at the north-eastern corner of the hammerhead on Possum Way, Warriewood.

#### 4.11 NARRABEEN WARD - ELANORA ROAD, ELANORA HEIGHTS - BARRIER LINES PROCEEDINGS IN BRIEF

The Traffic Committee supported this recommendation.

1. Installation of two-way Dividing Barrier Lines on Elanora Road, Elanora Heights.

#### 4.12 NARRABEEN WARD - WESLEY STREET, ELANORA HEIGHTS - BARRIER LINES

#### **PROCEEDINGS IN BRIEF**

The Traffic Committee supported this recommendation.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports the:

- 1. Installation of 22m of double Dividing Barrier Lines on Wesley Street at the intersection with Powderworks Road, Elanora Heights.
- 2. Installation of 15m of double Dividing Barrier Lines on Elanora Road at the intersection with Powderworks Road, Elanora Heights.

#### 4.13 NARRABEEN WARD - JACKSONS ROAD, WARRIEWOOD - 15MIN P TIMED PARKING RESTRICTIONS

#### **PROCEEDINGS IN BRIEF**

Phil Devon advised this restriction will only occur in the morning, as liaison with the school had identified that the issues were at drop-off times when parents dropped off children and not pick-up times with students tending to catch buses home.

The Traffic Committee supported this recommendation.

#### **RECOMMENDATION TO TRAFFIC COMMITTEE**

That the Traffic Committee supports the:
