- Multi-Use Parking Permits must be displayed in the holder on the front passenger side windscreen of the vehicle. Permit holders are available from Council.
- · All parking permit users must take responsibility to ensure the parking permit is valid and used in accordance with the terms and conditions.

Multi-Use Parking Permit: Owner occupiers, tenants and eligible second place of residence property owners

Eligibility:

To be eligible to apply for a Multi-Use Parking Permit, the applicant must:

- Live permanently at an address within an existing Manly parking permit scheme area.
- Provide documentation to the satisfaction of Council to support a second place of residence application.

Please ensure that you have read and understand the Manly Parking Permit Scheme Framework. PO Boxes located within the Manly area on documentation will be accepted

All applicants must provide: • Three (3) pieces of accepted documentation in the applicant's name at the property address, as detailed over the page or in the Manly Parking Permit Scheme Framework.	

Important Multi-Use Parking Permit information

- It is not a requirement to provide a driver licence, a NSW photo card or vehicle registration papers when applying for a Multi-Use Parking Permit.
- Multi-Use Parking Permits have been introduced to provide parking for visitors, tradespeople and carers of a rateable residential property.
- One (1) Multi-Use Parking Permit will be issued to each eligible residential property.
- A Multi-Use Parking Permit may only be replaced on presentation of a valid Police Event Number for a stolen permit only. Police will not provide an event number for lost permit
- If the applicant moves to a new residential dwelling within one of the existing Manly parking permit scheme areas, the existing Multi-Use Parking Permit must be presented to Council before a Multi-Use Parking Permit can be issued for their new parking permit scheme area.

Important information

The vehicle must not exceed 4.5 tonnes gross vehicle mass or greater than 7.5m in length.

The following property types are not eligible for a Manly Multi-Use Parking Permit:

- A household occupying a dwelling which was approved with the condition that no parking permits be issued.
- A household that has a second dwelling that has not been subdivided on a lot or for which parking permits are already issued.
- A dwelling not approved for residential use.
- Business rated properties.

Certain properties may not be eligible for a Manly Multi-Use Parking Permit as part of their Development Consent. Please check online to determine eligibility prior to submitting your application.

Statutory Declarations are:

- Not an acceptable form of documentation to prove residency within a scheme area.
- Not accepted to report lost or stolen Multi-Use Parking Permits.

This requirement is to minimise the risk of fraud.

Parking Permits cannot be swapped for other permits (E.g Residential Permit for a Multi-Use Permit) due to change of mind.
