Applicants may be contacted for further information.</li> <li>• All requests will be assessed against Council's Naming Our Reserves, Facilities and Roads Policy, the Geographical Names Board of NSW Policy - Place Naming and any relevant strategic directions.</li> <li>• All applications will be replied to in writing.</li> <li>• Proposals are supported and consistent with relevant policies and strategic directions will be placed on public exhibition for at least 2 weeks. Community feedback will be reported to Council.</li> <li>• If approved by Council, proposals for Reserves and Roads may be forwarded to the NSW Geographic Names Board (GNB) for consideration. Applications for naming a facility are determined by Council and implemented accordingly. The GNB is notified of these names to ensure the name, position and origin is recorded in the Spatial Services' Digital Topographic Database and the name shown on maps, where relevant.</li> <li>• Applicants will receive notification of the status of their application during the process including the final determination.</li> </ul>
