4.1 NARRABEEN WARD - CARAWA ROAD, CROMER - TIMED PARKING

PROCEEDINGS IN BRIEF

The representative for the Member for Wakehurst raised the following questions:

- Given the high number of objections to the proposal, why would the proposal proceed? Staff advised that the majority of objections were from the same address (being the group home across the road)
- Whether the building had parking. Staff advised that resident parking is provided on the lower level of the building.
- Whether 8HR or 12HR parking was an option. Staff advised that the intent is to encourage turnover of vehicles. Sufficient long-term parking exists at locations around the area, as this proposal only affected 5 spaces immediately in front of the property at 2 Carawa Road Cromer.

The Traffic Committee agreed to support the recommendation.

TRAFFIC COMMITTEE DECISION - RESOLVED

That the Traffic Committee supports the:

1. Installation of a Four Hour (4P) 8am – 6pm MON-SAT timed parking restriction approximately 20 metres in length outside No.2 Carawa Road, Cromer.

4.2 NARRABEEN WARD - RELOCATION OF BUS ZONE AND TIMED NO PARKING RESTRICTIONS - COLLAROY PLATEAU PUBLIC SCHOOL, COLLAROY PLATEAU

1. Relocation of Bus Zone and Timed No Parking restrictions next to the school driveway.

4.3 NARRABEEN WARD - SOUTH CREEK ROAD, FISHER ROAD NORTH AND MIDDLETON ROAD - ROUNDABOUTS, PEDESTRIAN REFUGES AND UPGRADE OF PEDESTRIAN CROSSING

PROCEEDINGS IN BRIEF

Police inquired about the engineering of the round about to accommodate heavy vehicles. Traffic officers advised this has been implemented into the plans.

Transport for NSW asked that the lighting meets Australian Standard. Phil Devon advised this has been implemented into the plans.

The Traffic Committee agreed to support the recommendation.

TRAFFIC COMMITTEE DECISION - RESOLVED

That the Traffic Committee supports the:

- 1. Installation of a roundabout at the intersection of South Creek Road and Middleton Road with pedestrian refuges on the northern and Eastern legs of the intersection.
- 2. Modifications to parking restrictions on the southern side of Middleton Road to include 18m of 15min Parking Mon-Sat
- 3. Modifications to the existing ½ hr Mon Sun, parking restrictions on the Northern side of Middleton Road to be amended to Mon Sat.
